
WHEREAS, the First Party desires to engage the Second Party to provide Manpower Services in the premises of the First Party in a manner conforming to the standards established by the First Party.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

Section 1 - Scope of services

- 1.4 The Second Party will alone determine the quantum and expertise of persons to be deployed and mobilised at the premises of the First Party to execute the scope of services under this agreement.
- 1.5 The Second Party and the First Party would jointly review the services provided by the Second Party in terms of this Agreement on regular basis, at mutually agreed periodicities. A service level agreement will be finalised for key performance deliverables.
- 1.6 The First Party shall provide all materials, consumables and equipment to the Second Party needed for carrying out the said services at the premises of the First Party, which factor is counted for determining the consideration under this agreement.
- 1.7 Vendor shall arrange an Area Manager visit for at least 2 hours daily to support the functioning of deputed staff at the site.
- 1.8 That the Service Provider (Second party) shall provide Housekeeping Management and Consultancy Services for the Public Area/rooms (herein after referred to as "The Services") at Hyatt Regency Delhi's or any of its place.
- 1.9 The Service Provider (second party) undertakes that its personnel deployed by it at the premises shall always be neatly and clearly dressed up, well groomed, disciplined and following good hygiene.
- 1.10 It is mandatory for the Service Provider (second party) to do the address and police verification of all it employees engaged at the premises of Hyatt Regency Delhi, keeping into consideration of the safety and security of hotel. The Company will provide the expenses, as per actual, to the Service Provider with respect to the verifications.

Section 2 - Consideration

2.1 In consideration of the provision of the Services by Second Party in accordance with the terms and conditions of this Agreement, the First Party agrees to pay to Second Party the charges set out in Schedule I (the "Charges"). The Charges as specified in Schedule I are exclusive of any taxes applicable including but not limited to Goods and Services Tax (GST) VAT and/or any other applicable taxes levied by the government or appropriate authority on the Services from time to time, which shall be charged in addition to the Charges.

Any services not included in this Agreement shall be performed by the Second Party only when previously requested by the First Party in writing. Any additional cost for such extra services shall be agreed to in writing by both parties prior to such extra services being performed. Any such extra services agreed to by the parties shall be subject to all of the terms and conditions set forth herein including, but not limited to, the insurance and indemnification provisions set forth herein.

The Second Party shall submit its bill to the First Party by the third of each month and the First Party would make the payments of such bills upon the verification within 60 days of receipt thereof. All payments made by the First Party to the

- 2.2 **Taxation/GST**-The Second Party shall be responsible to provide their GST registration number along with Harmonizes System Nomenclature (HSN) codes and Services Accounting Code (SAC) for the services by them to the First Party. In case the Second Party fails to deposit the GST collected on bill raised by them to the First Party by 20th of the succeeding month (due date of making GST payment to govt.) or if there is a mismatch in the outward details furnished by the Second Party with the inward details filed by the First Party and if the same is not rectified within a period of 30 days from the date of such mismatch appearing on the GST portal, the First Party would be entitled to recover the amount of GST charged on the invoices by the Second Party along with the interest as applicable.
- 2.3 The First Party may at its sole discretion permit the employees of the Second Party, deployed by the Second Party at the premises of the First Party to avail the facilities of one subsidized duty meal per day. Such duty meals shall be taken only in the designated place during its operational hours. Meal Facilities provided are subject to change and management reserves the right to make changes in meal facilities at its discretion
- 2.4 The Second Party agrees that it shall provide services to the First Party by deploying its persons who would always be in uniforms carrying the logo of the Second Party.
- 2.5 The First Party may at its sole discretion, for maintaining Hygiene and Safety standards extend the laundry services only for the uniforms of persons deployed by the Second Party.

Section 3 – Term / Termination

- 3.1 This agreement would come into force on and from **01st September 2021** and shall **remain in force till 31st August 2022**.
- 3.2 The First Party shall be competent to terminate this agreement at any point of time after giving one month notice to the Second Party. The Second Party, if it so desires, will be free to terminate the agreement by providing 60 days advance notice of termination stating reasons for such intent. Alternatively, the First Party will be free to terminate this agreement without any notice by paying the Second Party an equivalent of one month's consideration under this agreement (on the same basis and value draft as the last paid consideration). Such payment will be done through a bank draft or pay order. The Second Party will be liable to remove its deployment from the First Party's premises absolutely and unconditionally and in a manner befitting the spirit of this agreement on full and final settlement of the second party's dues. Upon such termination of the agreement, Second Party, including the persons deployed by the Second Party for the execution of the


services under this agreement will have no right of access or admission to the premises of the First Party.

- 3.3 Notwithstanding the provisions of termination of this Agreement by one month notice by first party and two months' notice by second Party, if the services rendered by the Second Party are not up to the requisite standards as agreed in the service level agreement and despite written advice of the First Party or otherwise, the Second Party does not improve the standards of its service and bring them to the requisite standards, the First Party shall be competent and entitled to terminate this Agreement forthwith, without giving any notice or payment in lieu of notice to the Second Party.

Section 4 – Legal / Statutory Covenants

- 4.1 This agreement is subject to the Second Party furnishing a proof of its valid registration and holding all valid licenses from the appropriate government authorities/ department for engaging in such services. These licenses shall form an integral part of this agreement.
- 4.2 The relationship between the First Party and the Second Party under this agreement is to be construed as one between two independent contracting parties on a principal to principal basis. There shall be no employer-employee relationship between the First Party and the persons deployed, engaged or employed by the Second Party and deployed by it for discharging its obligations under this Agreement at the above premises of the First Party. The employees of the Second Party shall, therefore never be deemed to be employees of the First Party under any circumstances whatsoever. It shall be the Second Party alone which shall be responsible for the payment of salaries, minimum wages, bonus, gratuity, overtime, leave-wages, provision of uniform, annual leave and other consideration or reward including compensation, compliance with Employees Provident Fund Act, Employees State Insurance Act, Contract Labour (Regulation & Abolition) Act 1970 (if applicable only) in addition to all the applicable statute's, in respect of all their employees so deployed at the premises of the First Party. In event of any notice to the First Party from any authority or court, or any loss suffered by the First Party in this regard, the Second Party shall indemnify the First Party in respect of any such loss or damage so suffered by the First Party.
- 4.3 The persons deployed by the Second Party in connection with the obligations under the agreement shall be direct employees of the Second Party only and such persons shall have no master / service relationship with the First Party. However, the First Party reserves the right to determine the expertise and competencies required for providing the said services at its premises in accordance with the laid down standards.
- 4.4 The Second Party will be responsible for compliance of all statutory and non-statutory obligations viz. obligations under Minimum Wages Act, Payment of Bonus Act, Payment of Gratuity Act, Employees Provident Fund and Misc. Provisions Act,



Employees State Insurance Act, Contract Labour Act. (if applicable), Workmen's Compensation Act and other relevant obligations including any industrial disputes in respect of its persons deployed at the hotel. The Second Party shall also be liable to comply with provisions of any other law or schemes, existing or coming into force in future relating to its persons deputed at the hotel, or relating to this agreement.

- 4.5 The Second Party agrees and undertakes to pay to the persons engaged by it for fulfilment of its obligation under this Agreement, wages not less than the minimum wages as prescribed by the Government of Haryana well as all statutory compliances. First party will not be responsible for non-compliance on the part of Second Party at any stage.
- 4.6 Every month, the second Party will submit to the First Party, a copy of challans for the previous month as proof of their depositing the specific EPF and ESI contributions by them with the concerned bank in respect of the persons deployed at the hotel. The Second Party will also furnish a due compliance certificate / Monthly or Annual Returns / Chalans every month, certifying that the second party is complying with all the statutory / non statutory provisions. - b) Process the Personal Information in accordance with this agreement/contract and applicable scope of work, if any ;

- m) not transfer Personal Information across a national border (other than to "Hyatt" or to a "Hyatt" affiliate), except:

 - (ii) subject to any additional requirements of "Hyatt" (which may, for the avoidance of doubt, require "Hyatt" to ensure such parties as are reasonably specified by "Hyatt" enter into the appropriate standard contractual clauses in the form approved by the European Commission).

B. Use of Sub-Processors:

- 1. C. Security of Personal Information:

- iii. a) description of the measures taken or proposed to be taken to address the Breach including, where appropriate, measures to mitigate its possible adverse effects;
 - b) perform an investigation to learn the cause of the Breach; and
 - c) promptly take any proposed steps communicated in accordance with Clause C(3)(a)(iii) above and all further steps necessary to remedy the event and prevent the Breach's recurrence; and
 - 4. fully cooperate with "Hyatt" to comply with any notification requirements that may result from such Breach. Rise and Shine India shall document and maintain adequate retention process and policies for all Breaches in accordance with all applicable legal and regulatory requirements.
- D. **Audit Rights:**
- 1. Rise and Shine India shall permit "Hyatt" or its designated representative (the "Auditor") to access any of the Rise and Shine India or its agents' or Sub-Processors' premises, personnel and relevant records as may be reasonably required in order to:
 - (a) fulfil any legally enforceable request by any government departments and regulatory, statutory and other entities, committees and bodies which, whether under statute, rules, regulations, codes of practice or otherwise, are entitled by any applicable law to supervise, regulate, investigate or influence the matters dealt with in this agreement or any other affairs of "Hyatt"; and/or
 - (b) Undertake verification that Rise and Shine India is complying with this Section."
 - 2. "Hyatt" shall use its reasonable endeavors to ensure that the conduct of each audit does not unreasonably disrupt Rise and Shine India or delay the provision of services Rise and Shine India and that, where possible, individual audits are coordinated with each other to minimize any disruption. Subject to "Hyatt's" obligations of confidentiality, Rise and Shine India shall provide "Hyatt" or Auditor with all reasonable co-operation, access and assistance in relation to each audit. "Hyatt" shall provide at least five (5) business days' notice of its intention to conduct an audit unless such audit is conducted in respect of a suspected fraud, in which event no notice shall be required. - 4. The parties may agree in writing that a third party report or certification (e.g., a SSAE 16-Type II report) provided by Rise and Shine India will satisfy the above audit requirements.

Section 6 - General Covenants

- 6.1 The Second Party will ensure that all services under this agreement are consistently and uninterruptedly rendered at all times to the complete satisfaction of the First Party, which only First Party has the right to determine.
- 6.2 Should the Second Party be unable to provide such services either in part or full, the First party shall have the right to engage the services of an alternate service provider and charge the Second Party with the entire cost of such an arrangement.
- 6.3 The Second Party shall furnish the names and addresses of the persons who will be deployed by the Second Party at the premises of the First Party. The Second Party undertakes not to deploy any person who is not of good character. The personnel would all be subject to due police verifications.
- 6.4 The Second Party shall ensure that all persons deployed at the premises of the First Party are subjected to Medical examination prior to them being assigned. The second party will not deploy any of their person who is suffering from any contagious or infectious disease or is not suitably attired or is ex-employee of the hotel. First Party shall be entitled to call upon the second Party to submit any of its persons for medical examination by a doctor who may be appointed by the First Party and the Second Party shall be bound to comply with such requirement at its own cost.
- 6.5 The Second Party shall ensure that all its persons deployed at the hotel perform their duties in a proper manner and under no circumstances shall violate rules and regulations framed by the First party nor any of the staff of the Second Party shall intermingle with the staff of the First Party. Persons deployed by the Second Party shall not carry on any activity, which is construed by the First Party as unjustified, unfair and illegal activity in and around the hotel. The Second Party further undertakes that none of its persons will indulge in any such activities which may interfere or hinder in the activities of the First Party nor the persons of the Second Party shall carry out any slogans, demonstrations either directly or indirectly and if in the opinion of the First Party, any activity of the persons of the Second Party is detrimental to the interest of the First Party or endangers the name and reputation of the First Party, the Second Party shall forthwith remove such persons on the written communication received by the Second Party from the First Party to that effect.

- to take insurance cover for employees / guests of the First Party towards public liability and fidelity. The Second Party agrees to furnish proof of such insurance cover to the First Party. Any claims made by the employees / guests of the First Party against injury, damage or loss caused to them by the employees of the Second Party will be settled by the Second Party. Should the Second Party be unable to settle any such claim, the First Party shall have the right to settle all such claims and charge the Second Party with the entire cost incurred by the First Party.
- 6.7 This agreement overrides and supersedes all prior writings and oral understandings between the parties hereto and accordingly in the event of any contradiction between any earlier writings and / or understandings in this agreement, the provisions contained in this agreement shall prevail.

Section 8 - Indemnification

- be entitled to hire or fire or discipline them. Similarly, the Second Party alone shall be liable to pay the wages, etc. to such persons.

This Agreement is made at New Delhi on this 1st November, 2020 between Asian Hotels (North) Limited, the owning Company of Hotel Hyatt Regency Delhi, a company incorporated under the companies act 1956 (hereinafter referred to as "Hyatt Regency Delhi") which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns and M/s. **ASHOKA TRAVELS & TOURS SERVICES PRIVATE LIMITED** having its principal place of business, at Khasra No 1165, Ground Floor, Near Kapil Warehouse, Rajokri, New Delhi- 110038 through its authorized signatory Mr. Ashok Yadav (hereinafter referred to as "Service Provider"), which term shall unless exclude by or is repugnant to the subject or context include its heirs, executors, legal representative and administrators.

WHILE the Hotel & Restaurant Business has become highly competitive, Hyatt Regency Delhi is a Five Star Deluxe Hotel, which primarily caters to foreigners including high dignitaries, Heads of business empires, Tycoons and their Indian counter parts, it is, therefore, imperative for the Service Provider to have proper Valet Services at Hyatt Regency Delhi to facilitate convenience of the guests, in consonance with International and Global Standards and thereby to remain competitive.

WHERE AS SERVICE PROVIDER has been engaged in business of specialized Valet Parking and Travel Desk Management Services, such services include all Valet Parking and Travel Desk Management, handling complicated parking, loud speakers, traffic flow, safety concern, guest arrival Valet Parking, Taxi Driver, commercial vehicle flow etc. and the expertise of the Service Provider includes planning and Demand analysis, feasibility studies and site selection, functional design, management analysis and operational audits - in nutshell, full range of Valet Parking and Travel Desk Management and Valet Service with special focus on enhancing parking efficiency by providing professional and efficiently managed parking solutions by its professionals and courteous employees. That the Service Provider shall provide specialized Travel Desk Services including but not limited to Valet Parking Management and Valet Services, Transportation Service for airport pick & drop, local run, office pick & drop, outstation travel solutions etc Place, New Delhi-110066. 02. In case hotel require additional chauffeur for operations or corporate office, service provider shall provide such chauffeurs on such terms and conditions as may be mutually decided between both the parties, currently four fixed drivers are being provided by service provider for GM duty, Vehicle for outdoor catering and private vehicles for corporate duty.

03. For Travel Desk Services, Service Provider shall use Cars as will be provided by Hyatt Regency Delhi as per the detail mentioned in Annexure-1. Service Provider will bear the cost of repair and maintenance, servicing and insurance, fitness test of each car provided by service provider. Airport Charges, Parking Fee, Airport Fees, Toll Tax, & State Taxes and further Operating Expenses of the car like Water, News Paper, tissue papers, fresheners etc. shall be borne by Hotel. 05. Hotel management is responsible to monitor the rates being charged from guests as per proper Market Survey and the service provider shall not have any say in fixation of these rates.
